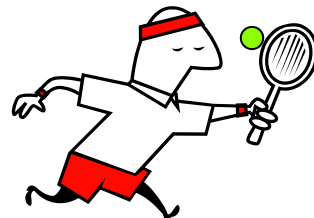

**DIRECTIONS TO GARDEN CITY COUNTRY CLUB – GARDEN CITY, NY (516) 746-8070**

**Long Island Expressway:** L.I.E. to Exit 34 (New Hyde Park Road); turn south onto New Hyde Park Road. Continue South to Stewart Avenue which is two traffic lights after Rail Road Crossing. Turn left onto Stewart Avenue, the Club entrance is one mile on the right.

**Southern State Parkway:** S.S.P. to Exit 17 North (Hempstead Avenue); proceed to the second traffic light which is Nassau Boulevard; make a left on Nassau Boulevard. Continue on Nassau Boulevard to Stewart Avenue which is the first Traffic light after the Rail Road Crossing. Turn left onto Stewart Avenue, the Club entrance is three blocks on the left.

**Grand Central Parkway/Northern State Parkway:** G.S.P./N.S.P. to Exit 26 South (New Hyde Park South); follow L.I.E. directions (above).
